Objectives for the Course:

- Identify and understand the attributes of good leaders, biblically and theologically
- Evaluate and strengthen their own identities and skills as pastoral leaders
- Explain and reflect on the nature of change in the local congregation and wider society
- Implement visioning, strategizing and planning process in their local congregations

Prior to September 14th:

Read all of Ducking Spears, Dancing Madly. After reading the book, explore the theology of leadership utilizing the book and the books of 1st and 2nd Samuel. Be certain to read the full biblical story that is mentioned in each chapter for better comprehension. After reading the book and associated passages, write a 3-5 page paper describing your theology of leadership. Be certain to include aspects of call, equipping, purpose and accountability as part of the theology. **(Email or mail this paper to Mike no later than September 2, 2018)**

Read all of Leadership and Self-Deception. After reading both books write a 3-5 page paper describing three significant issues that can adversely impact leadership and steps that can be taken to avoid these pitfalls. Be certain to reference the texts in your paper.

Bring this paper with you to class.

Read all of The Power of Positive Leadership

Prior to November 16th:

Over a 4 week period keep a log of all your pastoral activities including the event, and preparation time. An example would be:

Sunday: Led worship at 2 congregations – 9am – 1pm (4 hours)

Monday: Sermon preparation – 7pm – 8pm (1 hour)

Include all activities. The more complete this record the easier the following steps become.

Read The Strategically Small Church.

Do a 3-4 page assessment of your congregation answering the question: How are we

- Intimate
- Nimble
- Authentic
- Effective

As part of the assessment, note the strengths and areas in need of development. It is essential that you apply the elements of the text honestly in this process.

Read Finding Our Story: Narrative Leadership and Congregational Change

Write the two most significant stories told in your congregation. (If you have more than one congregation, you can select one congregation as a point of focus) Then answer the following:

1. How do the stories define your congregation?
2. Why is this story retold?
3. Does it empower or limit your congregation? Why?
4. If you could tell a new story to the congregation, what would it be?

This entire paper should not exceed 5 pages. You will have to be concise in your writing.

Bring these papers with you to class with you.

If you are uncertain of how to footnote, how to formulate a paper or want some guidance in writing I would encourage you to take advantage of the assistance offered.
